

MINUTES SPECIAL COUNCIL
REYNOLDSBURG CITY COUNCIL
October 7, 2003

President Pro Tempore Sarah Cannella called the meeting to order at 8:30 p.m.

Members of Council present: Sarah Cannella, Eric Gilbert, Mel Clemens, Ron Stake, Lane Beougher, William Hills. Councilman Jim Wade and Council President Bradley L. McCloud were absent.

ORDINANCE TO AMEND THE OFFICIAL ZONING MAP OF THE CITY OF REYNOLDSBURG ADOPTED BY ORDINANCE NO. 131-95 ON NOVEMBER 27, 1995 AND AS SUBSEQUENTLY AMENDED - 8450 EAST MAIN STREET; FROM R-1 TO CC; APPLICANT, KROGER REAL ESTATE BY GLEN A. DUGGER AND DECLARING AN EMERGENCY- - Clerk read ordinance by title for the one required reading. Mr. Gilbert moved to amend the ordinance by adding emergency language. Mr. Hills seconded the motion. All voted "Aye". Motion passed; ordinance amended.

Mr. Gilbert moved adoption. Mr. Hills seconded. With the roll called, members voted: Mrs. Cannella "Yea"; Mr. Gilbert "Yea"; Mr. Clemens "Yea"; Mr. Stake "Yea"; Mr. Beougher "Yea"; Mr. Hills "Yea". Motion passed; Ordinance No. 77-03 adopted.

Clerk read motion: That the Chief of Police be and is hereby authorized and directed to advertise for bids for mobile computers and related equipment, including software, for the Reynoldsburg Police Department. (U. S. Department of Justice COPS MORE 2002 Grant was accepted by Ordinance No. 105-02 passed November 12, 2002). Mr. Clemens moved adoption. Mr. Stake seconded. All voted "Aye". Motion passed.

Request for Executive Session by Mr. Clemens for conference with City Attorney concerning imminent court action.- -Mrs. Cannella moved to recess for Executive Session. Mr. Beougher seconded. With the roll called, members voted: Mrs. Cannella "Yea"; Mr. Gilbert "Yea"; Mr. Clemens "Yea"; Mr. Stake "Yea"; Mr. Beougher "Yea"; Mr. Hills "Yea". Motion passed. Mrs. Cannella said following Executive Session, Council would reconvene only to call the roll and adjourn. Council recessed at 8:34 p.m.
