

MINUTES REGULAR COUNCIL MEETING
REYNOLDSBURG CITY COUNCIL
June 11, 2012

President of Council Doug Joseph called the meeting to order at 7:31 p.m.

Members of Council present: Scott A. Barrett, Leslie Kelly, Mel Clemens, Barth R. Cotner, Chris Long, Nathan Burd. Councilman Cornelius McGrady III was absent.

The Invocation was given by Councilman Burd. Mr. Joseph led the Pledge of Allegiance.

Minutes of the regular Council meeting held May 29, 2012 were approved without objection.
Minutes of the special Council meeting held June 4, 2012 were approved without objection.

The agenda was approved.

Communications- - Clerk read that Council was in receipt of the Budget by Classification document received from the City Auditor on June 7, 2012 and was through April 30, 2012.

Reports- - Mr. Joseph said the Charter Review Commission had concluded their business and would be forwarding items to Council once they had been reviewed by the City Attorney; that there would be five or six items for Council to look at that the Commission felt Council and the voters should consider.

Mr. Joseph also said he would be making a recommendation during the next Finance Committee meeting of names of persons to serve on the Ward Boundary Commission; then Council could consider making the appointments so the city's boundaries could be considered for changes.
