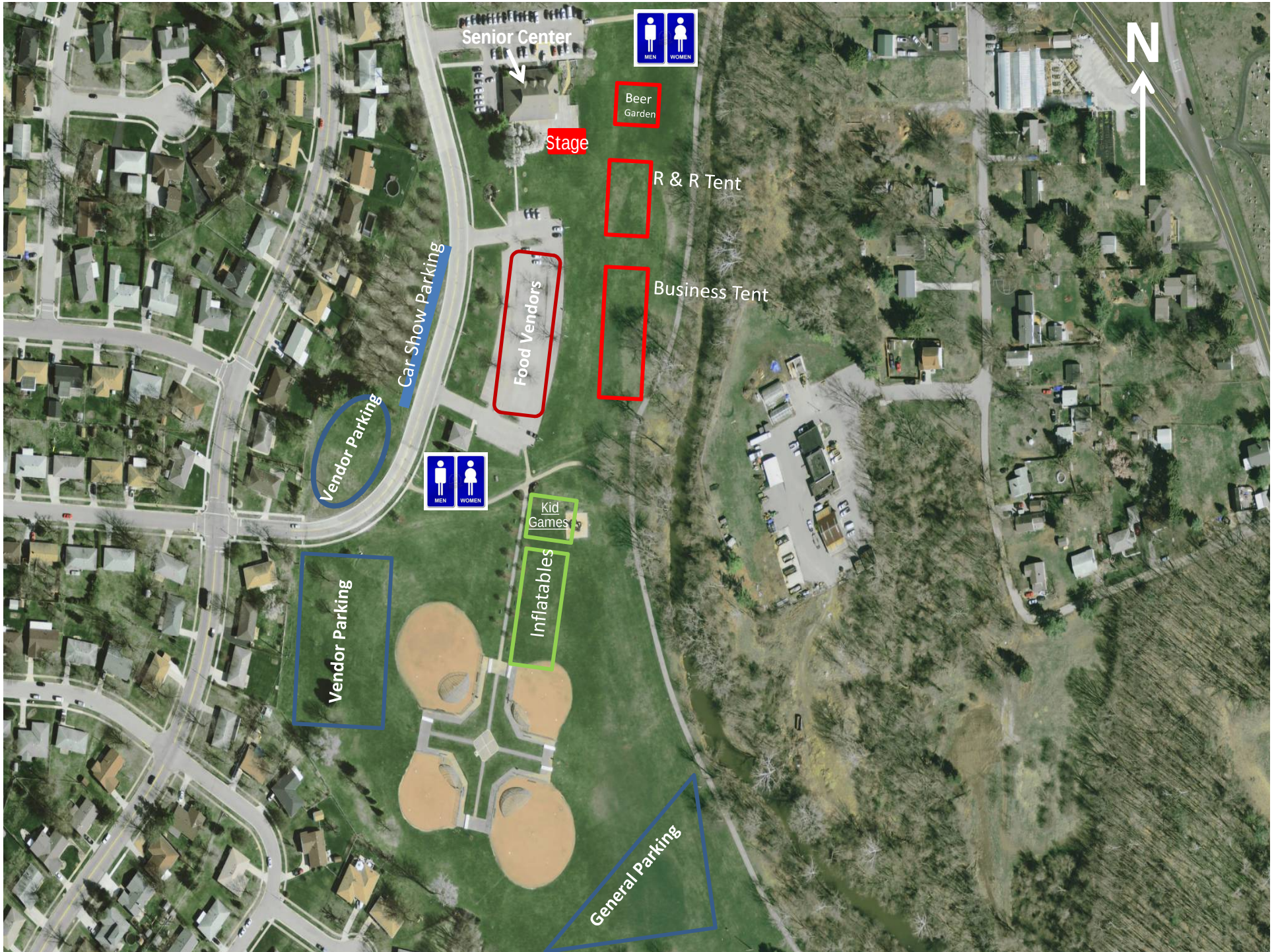

Requesting permission to waive the provision for section 971.16 of the codified ordinances for the 2017 Tomato Festival, as was waived in 2012, 2013, 2014, 2015 and 2016. The Beer Garden will be operational from 5pm-10pm on Friday, August 18, 2017 and from Noon-10pm on Saturday, August 19, 2017. The area will be completely enclosed with patrons being able to see the stage and entertainment. The Tomato Festival Board of Directors will gather and obtain all necessary permits required, follow all training requirements and will work closely with the Reynoldsburg Police Department and the administration to assure that all security measures meet the highest standards as they did during the 2016 Tomato Festival.
